5. <u>Consideration of a Motion to Consolidate the Appeals of Eric Curlee (Docket No. 18-239 and 18-243-S).</u>

Commission Referee Lenore Feeney advised that two appeals are pending for Mr. Curlee. Following a prehearing conference, appellant's new counsel asked to represent him on both matters and filed a motion to substitute. Ms. Feeney recommended that the appeals be addressed together rather than separately.

On motion duly made by Vice-Chairman Knapp, seconded, and unanimously passed; the Commission voted to Consolidate the Appeals of Eric Curlee (Docket No. 18-239 and 18-243-S).

A request was received from Mr. Leon Millet to address the Commission. Mr. Millet reminded the commissioners that on January 10, 2019 he filed a formal complaint pertaining to political contributions. He advised that he has not received a response from the governor. He asked the Commission to work toward a resolution in the matter and advised his belief that the governor should either exonerate the accused or call for public a hearing.

Chairman Simien advised that the Commission had appropriately responded to the complaint by providing information to the governor.

VIII. Director's Report

Expenditures:

The attention of the Commission was directed to the Commission's Monthly Expenditure Report that had been provided for its review. There were no question or comments about the Report.

Proctor U:

The director advised that an agreement had been reached with ProctorU for online web-based cadet testing. Staff were working with the implementation team to receive training on the new processes and completed the conversion of all cadet exam versions into an electronic format. Two individuals were already in queue to participate in the online exam.

Chairman Simien highlighted the benefits to local applicants that may be unable to make the regularly scheduled monthly exam.

Vice-Chairman Knapp inquired about the timeline to which Director Hannaman advised the hope to have several tests conducted prior to the next commission meeting.

Commissioner Mire provided his thanks for the many meetings, hard work, and coordination that took place in the process and his belief that it will benefit both the applicants and the Louisiana State Police.

Commissioner Riecke provided his thanks for moving forward on the efforts to streamline the cadet testing process.

Prior to adjournment, Commissioner Riecke recommended an upcoming five-part documentary-series based on the book *Murder in the Bayou*. The series will air on Showtime and focus on local corruption and unsolved murders in Louisiana.
